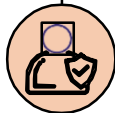

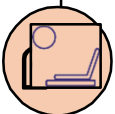

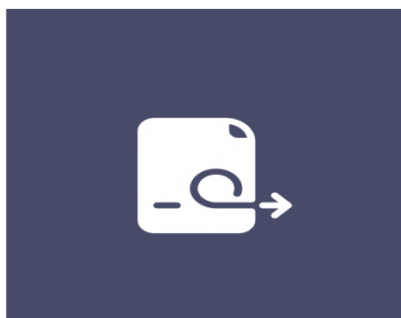
PRO Services
